HSC Club Registration Fees are for the full season and not a month to month commitment. Club Registration Fees are separate from individual Team Fees. Team Fees are established by each team's coach and team parents based on tournaments and other team activities the team decides upon.

If electing to pay HSC Club Fees over time, it is understood that the Club Registration Fees are incurred and due in full upon registration and that the installment plan is a means for players/parents to pay the Fees over time instead of paying in-full at the time of registration. The installment plans are not intended to imply an installment is for a specific time period with an HSC team; They are incurred in full at the time of the initial registration.

**Heritage Soccer Club Fees and Refund Policy**

**You must acknowledge that you read and understand the Heritage Refund Policy to Register.**

**Initials Required. I acknowledge that I read and understand the Heritage Fees and Refund Policy:**

Heritage Soccer Club Registration Fees:

Club Registration fees are due and payable upon player registration, though the club does offer payment plans. If you choose a payment plan, the total registration fee must be paid in full by the end of the current year of registration. Any player whose fees are not paid by that date must make arrangements with the club or their child's player card will be revoked. Further, any player on a payment plan who is more than 2 month in arrears on their payment plan will have their player card revoked and will not be permitted to play any games with their team until their fees are brought current or other arrangements are made with HSC.

Any parent who is paying for their child on an automatic payment plan explicitly authorizes HSC to continue charging their credit card should that player leave HSC for any reason, unless a refund of registration fees has been authorized by HSC in the event the player is injured or moves out of the club geographic area.

Heritage Soccer Club Refund Policy:

If, after registering and committing to play on a Heritage Club Soccer Team, the parent/legal guardian of a registered player decides to leave the club or to no longer participate as a youth soccer player for the club, then partial refunds maybe available. Refunds are only available for season ending injuries (doctor's verification may be required) or if player moves out of the club's geographic area. Refund amounts are based on a sliding scale determined by the request date or injury date and are subject to a \$100 processing charge. In addition, the \$100 Volunteer Fee will be returned only if the volunteer bond was paid and the position was completed. All Club Registration fees are due and payable if a player leaves a team for any other reason. Refunds are not given for time while training with the team or if the player is transferring to another club. Further, the player's card will not be released until their account with HSC is paid in full.

Request for a refund must be made in writing by emailing [President@HeritageSC.com](mailto:President@HeritageSC.com) or sending a letter to Heritage Soccer Club, PO Box 5613, Concord, CA 94524. A \$100 processing charge is deducted from all refunds.

**PARENT/GUARDIAN AND ATHLETE AGREEMENT REGARDING CONCUSSIONS**

As a Parent and as an Athlete it is important to recognize the signs, symptoms, and behaviors of concussions. By signing this form you are stating that you understand the importance of recognizing and responding to the signs, symptoms, and behaviors of a concussion or head injury.

Concussions and Head Injury Law: Enter in your name to acknowledge that you understand and agree as a Parent/Guardian, and for your player being registered to play competitive soccer, that it is important to recognize the signs, symptoms, and behaviors of concussions. A concussion information sheet is provided to all players that must be signed and returned by the parent/guardian and player. If a concussion/head injury is suspected, from any activity related to HSC soccer or not, your child/guard must be removed from practice/play. You understand that your child/guard cannot return to practice/play until providing written clearance from an appropriate health care provider to his/her coach.
